



## **LIABILITY RELEASE FORM**

The Village Experience, LLC, is defined to include its owners, agents, directors, officers, employees, representatives and affiliates, (collectively “Village Experience”). Off The Mat Into The World is defined to include its owners, agents, directors, officers, employees, representatives and affiliates, (collectively “OTM”). Seane Corn is defined to include its owners, agents, directors, officers, employees, representatives and affiliates. Suzanne Sterling is defined to include its owners, agents, directors, officers, employees, representatives and affiliates.

Village Experience, OTM, Seane Corn, and Suzanne Sterling do not own or operate any entity which is to or does provide goods or services for your trip including, for example, ownership or control over hotels or other lodging facilities, airline, vessel, bus, van or other transportation companies, local ground operators, providers or organizers of optional excursions, food service or entertainment providers, etc. Village Experience, OTM, Seane Corn, and Suzanne Sterling are not liable for any negligent or willful act or failure to act of any such person or entity, or of any other third party.

Without limitation, Village Experience, OTM, Seane Corn, and Suzanne Sterling are not responsible for any injury, loss, or damage to person or property, death, delay or inconvenience in connection with the provision of any goods or services occasioned by or resulting from, but not limited to, acts of God, force majeure, acts of war or civil unrest, insurrection or revolt, strikes or other labor activities, criminal or terrorist activities of any kind, overbooking or downgrading of accommodations, structural or other defective conditions in hotels or other lodging facilities, mechanical or other failure of airplanes or other means of transportation or for any failure of any transportation mechanism to arrive or depart timely, dangers associated with animals, marine life or vegetation of any sort, dangers incident to recreational activities such as scuba diving, snorkeling, swimming, kayaking, sailing, canoeing, rafting, hiking, bicycling, rock climbing, etc., sanitation problems, food poisoning, lack of, access to or quality of medical care, difficulty in evacuation in case of medical or other emergency, or for any other cause beyond the direct control of Village Experience, OTM, Seane Corn, and Suzanne Sterling.

**PERSONAL RESPONSIBILITY.** The Village Experience passengers have the responsibility to join a program appropriate to their physical and mental ability and interest. It is expected of each passenger to act in accordance and with respect to the local custom, cultures and laws of the regions visited. The Village Experience Guide has the right to

Refunds are not given under any circumstances. The Village Experience reserves the right to accept, retain or decline any passenger at any time for any reason. Emergency contact will be responsible for any communication with law enforcement, the appropriate embassy, hospitals or judicial proceedings in the unlikely event that this is necessary. I understand that this is not the responsibility of the Village Experience Guide.

**ASSUMPTION OF RISK AND WAIVER.** I am aware that travels such as those which I am undertaking involve hazardous activities, some in remote areas of the world, with a risk of illness, injury or death which may be caused by forces of nature, or other persons and companies known or unknown, or of willful or criminal conduct of third parties. I am also aware that medical services or facilities may not be readily available or accessible during some or all of the time during which I am participating on the trip.

I accept these risks and obligations and I fully assume the risks of travel. I fully and forever release and discharge The Village Experience, OTM, Seane Corn, and Suzanne Sterling from any and all costs (including, without limitation, actual legal costs), claims, demands, actions, causes of action and liabilities whatsoever for any and all losses, damages, death or injuries to persons or loss of property, which may be sustained by me in connection with or in any way relating to this trip, due to any cause or reason whatsoever with exception to any willful or negligent acts of the Village Experience, OTM, Seane Corn, and Suzanne Sterling.

**KNOWING AND VOLUNTARY EXECUTION.** I have carefully read this Agreement and fully understand its contents. I am aware that this is a release of liability and a contract between myself and Village Experience, OTM, Seane Corn, and Suzanne Sterling, and its employees, officers and agents, and sign it of my own free will.
